Appearance and Clothing Instructions at University

Based on the directives of His Royal Highness the Minister of the Interior, Nos. 32-101963 and 19-12-1421, and the directives of His Royal Highness the Amir of the Eastern Region, renewed on September 18, 1425, A.H., regarding the requirement to adhere to proper dress, good organization, and observance of public morals when entering government buildings, mosques, and official ceremonies because this is a civilized, religious, and literary appearance that must be taken, and so that official ceremonies are conducted

Based on this order, the university has established rules and guidelines for attire, uniforms, and public appearance throughout the university generally, including academic buildings and public facilities. These rules and guidelines are based on four pillars:

First: The need that Saudi attire be preserved, save for activities like schooling and physical exercise that call for safety.

Second: refrain from dressing or acting in an extreme way that makes you look like a non-Muslim.

Third: Shifting students away from similarity and away from similarity (for female students).

Fourth: The relationship between the dress is a full-fledged character.

Dress Instructions and Characteristics for Hafr Al-Batin University Students:

First: Students at Hafr Al-Batin University are expected to dress and present themselves in a way that is consistent with both the moral and ethical traditions and teachings of Saudi culture as well as the tenets of our faith.

Second: The following requirements must be met by the appearance and attire of Hafr Al-Batin University students:

For male students it is strictly forbidden:

1. Wearing short pants of any kind, blouses with exposed shoulders, outfits that could expose one's nakedness, and outfits that contain offensive language are all examples of improper attire.
2. Female attire and unusual hairstyles, such as the use of ties and hair collars.
3. Bizarre hair colors and cuts.
4. Hair color and various forms of tattoos.
5. Wear bracelets, chains, and other jewelry.

For female students it is strictly forbidden:

First: Only when entering and leaving the college, students are required to wear the abaya.

Students are not permitted to enter or wander around the college wearing the abaya

Second: The following actions are expressly prohibited:

- Putting on see-through, short, and fitted clothing (allowing for the sweatshirt)
- Wearing pants (except for medical colleges, they are allowed to wear medical uniforms and the coat is a long coat to the knee level, which is wide, loose, and closed)
- Body painting or tattooing
- Wearing an edgy, eye-catching, or colorful abaya
- It is against the law to dress and have a haircut like men
- No shirts, blouses, or bags with images, designs, or words that go against our religious principles are permitted.
- It is not permitted to wear overt colors that are inappropriate for an academic setting.

For female students in the medical college (who are training in hospitals), the following shall be required:

1. A medical uniform may be worn with scraps
2. The coat must be covered in a long, wide, and broad coat that is buttoned up to the knee
3. The use of fragrances is prohibited.
4. Makeup is prohibited.
5. Adherence to the proper veil protocol and a commitment to covering one's hair.
6. To avoid causing patients and hospital visitors any difficulty, heels are not permitted.

Third: The following sanctions will be applied to any student who disobeys university rules on appearance or address:

First:

When it's the first time:

1. Individual spoken instructions given to each pupil by the appropriate authority are recorded by signing a pledge.
2. Explaining in detail the university's dress and appearance rules to the student in order to ensure that they are aware of them and what will happen if they violate them again.

Second:

If the infraction happens again:

The student signs a pledge, and in the case of a female student, her guardian also swears to uphold the university's norms and regulations and not to do the same thing again.

Third:

If the student persists in breaking the rules and commits the offense a third time, the college's behavior control unit investigates the situation and makes recommendations before imposing the necessary punishment with parental notification.

Fourth:

In situations where there is no provision in these regulations, the University President or his representative may offer suggestions.

Fifth:

All students at the University of Hafr Al-Batin and all of its affiliated colleges must abide by the terms of these regulations, and they must begin working as soon as they are made public.

Sixth:

The authorities responsible for enforcing these regulations' provisions must take into account their publication and announcement to students (both male and female), each in his or her individual capacity.
