Conditions for Visiting Students from One University to Another

Article Fifty:

A visiting student is a person who takes a few classes at a different college or branch.

According to the following controls, the university to which he belongs without transferring him and the courses he took are similar to his:

- a. Prior to the study, the college where he is enrolled must have given its approval.
- b. The education must take place at an accredited institution or university.
- c. In terms of vocabulary, the course the student is taking outside of the institution should be equivalent to or (equivalent) to one of the courses required for graduation.
- d. The transaction must follow Article 47 if the visiting student is studying at a campus of the university to which they are a member. The maximum proportion of units of study that can be calculated for a visiting student from sources other than the institution is set by the institution's Council.
- e. Then there is. A visiting student from another university's equalized course averages are documented in his academic record but are not included in his cumulative average.
- f. Any additional requirements imposed by the University Council.

Executive Guidelines for Article 50 First: a student from the University of Hafr Al-Batin who is a guest at another college:

- Research Across a Semester:

a. The student notifies the head of his academic department in writing of the course(s) he plans to take outside of the university and submits the request. A committee is established by the department council to research these courses and suggest similar courses for this university. If the student was unable to get approval before the course or courses, he may submit his application after they are finished.

b. After finishing her studies, the student files a request for a course equivalency to the Deanship of Admission and Registration. A decision is made regarding whether or not to accept the course per the executive rules of Article 43.

c. Without affecting the criteria for graduation, a student may earn up to (48) credits from sources other than the university as long as their overall grade in each course is at least (good) or equivalent. (C).

d. The most semesters a student can spend studying away from the institution is three, whether they are consecutive or not. (except for the summer semesters).

e. The University of Hafr Al-Batin gives the award to the visiting student in accordance with the rules governing that.

Second, A Guest Student from Another Institution or University to the University of Hafr Al-Batin.

• Summer or Semester-Long Study Sessions:

- a. The student must present authorization from the educational institution where he is enrolled, outlining the reasons for taking those courses elsewhere and attesting that he satisfies the prerequisites for the courses he wishes to enroll in.
 - b. The presence of the location where registration is intended within the headquarters.
 - c. In order to be admitted, a visiting student from outside the university must have completed a semester of normal coursework in the college where he was enrolled and have at least 12 credits of grades recorded in his academic record.
 - d. Student who has previously been denied access to one of the courses they took as a guest at the University of Hafr Al-Batin is not permitted to enroll as visiting student at the University of Hafr Al-Batin or any of its affiliates.
 - e. No matter if he attended the institution on a temporary basis or regularly, all of his academic endeavors are documented in a single academic record.
- Then there is. The visiting student may get textbooks in accordance with the relevant regulations.
- f. A student enrolled in distance learning will not be approved until he has been admitted to his university as a regular student and has completed at least twelve credits of coursework.

g. The Deanship of Admission and Registration oversees all aspects of visiting and from the university. Requests for visits must be accompanied by a letter from the dean of admission and registration at the other university that details the student's intended program of study at the University of Hafr Al-Batin.

h. The visiting student's civil registry number is also his academic identification at the university.

i. A student from outside the Kingdom of Saudi Arabia must attend a university or college that is regularly operating and recognized by the Ministry of Education, and he or she must have a grade of at least good (C).

Third: A guest student at One of the University of Hafr Al-Batin's Branches.

• Summer or Semester-Long Study Sessions:

a. For a student to visit another college within the university, his college must first give its approval. This approval must describe the courses the student will take in the other college, which must be equivalent to those in his own college's plan.

b. The visiting student must have completed a semester of normal study in the college to which he was admitted and have grades of at least 12 credits assigned to him in his academic record in order to be accepted among the university's faculties.
