#### **General Provisions**

- 1. The person who is housed undertakes not to obtain housing from another party.
- 2. The Housing Department has the right to ensure that the resident and his family members live in the housing and that the housing is not used for other purposes, and if he/ she is not permanently present in the housing unit, he is required to leave the housing unit.
- 3. Correspondence sent by the Housing Department to the place of residence shall be deemed to be received if it is delivered to him/ her personally or to a member of his family, as well as the correspondence sent to the University's e-mail.
- 4. Residents shall abide by the regulations and instructions issued by the University and the amendments or additions thereto. This includes traffic regulations, the organization of accommodation facilities, the rules of public morals and the Islamic ethics of appearance and conduct.
- 5. If a resident's car stands in violation, the traffic violations law shall apply to him.
- 6. Residents must maintain the cleanliness of the residential neighborhood and the safety of its assets.
- 7. The university does not compensate the resident materially for harm or damage of any kind resulting from fires, water leaks or damage to the building facilities caused by the resident.
- 8. The University shall not be bound by any monetary or in-kind compensation to the faculty member in the absence of a vacant housing unit, except for those whose housing allowance is provided for by the regulations.
- 9. The resident shall maintain the housing unit and its contents and shall not introduce any changes to the housing unit allocated to him without prior permission from the university.
- 10. Dumping garbage and waste in designated places shall take into account after placing it in sealed plastic bags.
- 11. Residents shall deal with respect and appreciation to other residents, supervisors, security personnel, and service workers inside the residential complex, and refrain from harming others in any way.
- 12. Residents should rationalize their electricity and water consumption. Legal procedures will be applied in case of misuse, and these procedures may amount to a request for leaving the housing unit.
- 13. The resident is fully responsible for his actions, the actions of his visitors, all the people living with him, and those who work for him. He/ she bears all compensation for the damage resulting from them, which occurs inside the housing unit or inside the residential complex. non-payment or delay in payment, the university has the right to deduct it from his/her financial dues.
- 14. Residents shall immediately report the breakdowns of the housing unit and allow housing supervisors and maintenance officials to enter the residential unit in urgent and dangerous situations, whether the resident is present or not.
- 15. Residents should allow specialists to enter the housing unit to perform preventive maintenance.













- 16. Residents shall not change the locks of the housing units without prior permission from the university and provide a copy to the housing Department.
- 17. Disturbance of residents shall be prohibited. Children shall be prohibited from playing or storing bicycles and personal property in undesignated facilities and on the walkways of buildings. If it exists, it will be removed without any responsibility on the university.
- 18. Tampering with or damaging housing units are Prohibited, including pin-ups on walls or doors or making openings or extensions thereof.
- 19. Housing of male drivers and servants in apartments is forbidden.
- 20. It is prohibited to keep pets, with the exception of fish and birds.
- 21. Housing workers shall not be employed in private jobs inside a housing unit or in car wash.
- 22. It is forbidden to employ workers who are not sponsored by the resident, and the resident shall bear the legal responsibility as a result.
- 23. It is forbidden to employ workers who are not under the sponsorship of the resident, and the resident bears the statutory responsibility as a result.
- 24. Residents must take all safety measures to maintain their apartments. in case of travel, water locks should be shut, disconnecting electrical and electronic devices from electricity, and shutting windows and doors.
- 25. Residents shall secure and maintain the furniture and electrical appliances they need at their own expense. Coordination with the Department of Operating and Maintenance is required to match the devices with the electrical grid. In case of violation, residents shall bear the damage that may result from this violation.
- 26. Housing units shall be handed over to the Housing Department at the time of residence, thus obtaining a record clarifying the obligations and responsibilities of the housing unit.
- 27. Residents shall be obligated to pay all their dues for services (electricity, water, sanitation, and telephone). If residents do not comply, the university shall have the right to deduct them from their dues.
- 28. When the house is vacated or the car is sold to others, the occupant must return the entry card, even if it is torn.
- 29. The right of the resident to continue living shall be forfeited:
- If the resident violates the regulations of the Kingdom of Saudi Arabia, or the regulations, rules, and instructions issued by the University.
- Misuse of housing, causing harm to neighbors and residents, or violating the instructions contained in these regulations.













- If the inhabitant uses the housing unit for other than its assigned purposes, rents it or allows others to use it, or violates public regulations and morals.
- If the resident made any additions or modifications to the residential unit without adhering to the rules set by the university, or if he encroached on the ground in the residential neighborhood.
- If the housing unit is used in a way that would harm the building, the environment, or others.
