Regulations on the Use of Mobile Phones and Their Provisions in the University

For male and female students, the following shall be followed:

1. Never use a cell phone Use of the lecture hall and laboratory is only permitted during lectures and practical lessons, and only in public areas like gardens, buffets, and eateries that are designated areas on the academic campus. If a student or student violates the rules, the following rules will apply:

The first time: The youngster was asked to promise not to repeat what happened the first time

The second time: The student receives a written warning of the offense the second time.

The Third time: The student is referred to the Faculty of Conduct Control Committee for the third time.

1. Bringing a cell phone into the exam room is strictly prohibited. In the event of a seizure, the student/student will be charged with cheating and will be held accountable.

2. Any official papers, documents, or documents that the student or student has no right to see are forbidden from being photographed.

3. If a student violates the rules, the following rules will be in effect:

The first time: suspension for one semester with parental notification.

The Second time: suspension for two semesters with parental notification.

The Third time: suspension for three semesters with parental notification.

4. Facilities at universities may not be photographed. The following rules will be followed in cases of violation:

The first time: a written warning.

The second time: The guardian was informed via written warning.

The third time: a one-semester suspension with notification to the parent.

5. According to the Cybercrime Prevention System, it is illegal to misuse mobile phones with cameras or their counterparts in order to violate the privacy of others.

6. Faculty and staff personnel are not allowed to capture audio with the goal to offend or slander anyone.

The following rules will be followed in cases of violation:

The first time: suspension for one semester with parental notification.

The Second time: suspension for two semesters with parental notification

The Third time: suspension for three semesters with parental notification

7. The deans of the colleges must submit the student to the committee qualified to look into the college and take the required action against him when a complaint is made regarding the improper use of a mobile device.

8. It is against the law to take pictures of female students, faculty, staff, patients, and visitors at the university's medical facilities. The equipment will be seized and the incident will be looked into by the Behavior Control Committee if there is a violation. Given the circumstances of the incident, the committee may suggest the most appropriate course

of action, which may include proposing the ultimate sanction of removal from the university.

9. University visitors are warned by security officers not to use their phones' cameras. Visitors are under the supervision of a security guard and are required to turn in their phones to the trustee box. a link stating that the guest receives their phone after checking out and keeps their phone in the guardian's box.

Important Notes:

- All students, both sexes, should make a commitment to always have their ID cards on them when they are on campus.
- Even if the photo was taken for the first time, the institution has the power to impose a harsher punishment in the event that it leads to any kind of defamation, with the goal to offend or injure, in any social media platform, online, or elsewhere.
- These sanctions apply to offenses committed on university property
- In accordance with the cybercrime law and other rules, the people who were elected or the university may assert a particular privilege.
- The device shall not be released in the event of seizure until the owner or holder of the private right and her guardian has waived in writing, in order to protect his germination evidence before the appropriate authorities.
